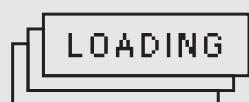
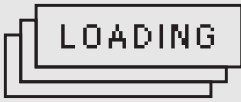


Loading Festival

OPEN CALL - LEGAL BASES





The association Planeta Dispara, headquartered in Porto, number A-48265169, organizes the present "Open Call for Projection Night", which will be governed by the following legal bases (hereinafter, the "Legal Bases").

1. Objective

The purpose of Open Call is to promote projects in the field of audiovisual art.

2. Submissions deadline and Period of validity

The period during which you can register to participate in the Open Call will begin on August 2 at 00:00 p.m. (GMT) and will end on August 23 at 00:00 p.m. (GMT) both inclusive. This period can be modified by Planeta Dispara, who will communicate it through the web indicated in section 4 of these Legal Terms.

3. Territorial scope

Portugal and International.

4. Conditions of participation

4.1 The Contest is intended for artists and art students, photography, cinema and design, both individual and collective, who meet the requirements indicated below, along with any other requirement that is established in these Legal Terms.

4.2 Contestants aiming to participate in the Open Call must register and send all the requested information compressed in a .zip file through the electronic mail loadingopencall@gmail.com, to participate in the Open Call:

- (i) TITLE & SUMMARY DO PROJECT (500 CARACT. MAX)
- (ii) Name or social reason of the artist or social reason of the collective
- (iii) EMAIL

PHOTOGRAPHY PROJECTS

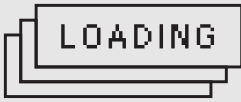
*10 to 15 images, in JPEG, 72 dpi, Loose files, with nomenclature

VIDEO PROJECTS

* Video files max 5min., In MOV / MP4, 1920x1080, with nomenclature

4.3 Participation in the Open Call requires that the Participants submit a single Project related to the following statement:

At Loading nothing is finished, in the festival everything begins, everything changes but nothing is closed. It cannot be presumed, it cannot be boasted, it shows processes and fragments to grow and improve. In this way, public, creators, institutions and all participating agents are enriched by the knowledge, debate, and sharing of similar processes.



4.4 Participation in the Open Call is free.

4.5 The Contestant may not submit more than 1 (one) project.

4.6 The acceptance of these Legal Bases is a necessary condition for participation in the Open Call.

4.7 The Participant must provide accurate and proprietary information. In case you don't, your participation will not be considered and therefore, you will be excluded from the Open Call.

4.8 The presentation of any Project implies the presumption of its authorship, with the consequences that derive from it, the ownership of the rights of authorship, of diffusion. It will be the responsibility of the Participant to assume the consequences of any claim in relation to the authorship of the Project and the use of their rights.

4.9 All Participants of which the Project is selected in the Open Call must assign the rights of public communication during a period of five (5) years both for the projection of the Project and for the communication and promotion of Planeta Dispara and any of its activities.

4.10 Participation in the Contest implies acceptance of these Terms and Conditions.

4.11 The Participant may consult these conditions on the Web <http://loadingfest.com> (hereinafter "THE WEB") at any time during the corresponding Term.

4.12 Planeta Dispara reserves the right to change this current Legal Terms. As the right to change the mechanics of participation.

5. Notification and acceptance of the Selected Projects.

5.1. Contestants whose Projects are selected will be notified by Planeta Dispara via email using the email address delivered at the time of presentation of the project before September 7, 2019.

5.2. The acceptance of the selection is automatic and does not require any procedure on the behalf of the Participant.
